4. Agreement

By submitting this application you accept and acknowledge the following matters:

- You will be required to pay an amount in relation to the installation of the necessary meter. The amount of the charge will depend on your local distributor. We will pass this cost on to you through your energy invoice. We can confirm the amount you will need to pay for the meter installation upon your request.
- It is your responsibility to ensure that any electrical work that is needed to accommodate your new tariff is carried out at the appropriate time.
- Prior to submitting this application you have read a copy of the appropriate Victorian Feed-in Tariff terms and conditions published by us pursuant to section 40G of the *Electricity Industry Act 2000 (Vic)* (copies are available on our website) and that you understand and provide your Explicit Informed Consent to those terms and conditions and agree to enter into an agreement with us on those terms and conditions.
- The Feed-In Tariff you receive for generated electricity fed into the grid will be set out in the terms and conditions, and will be published on our website, You give your Explicit Informed Consent that your Feed-In Tariff can change from time to time, in-line with the Applicable Regulations. If the Feed-In Tariff does change you will be notified on your next bill or as required by the Applicable Regulations.
- By switching to a new Feed-In Tariff you may:
 - permanently lose any entitlement to take advantage of particular tariffs such as: controlled load, dedicated circuit (e.g. hot water and slab heating) and climate saver tariffs. This decision will be made entirely at the discretion of your local distributor.
 - be moved to a time of use tariff. This decision will be made entirely at the discretion of your local distributor. Once this occurs you will no longer be able to take advantage of other types of tariffs. You give your Explicit Informed Consent that we may reassign the tariff that you are charged under our Supply Agreement for the sale and purchase of electricity.
- If you are an existing Alinta Energy customer you give your Explicit Informed Consent to be transferred from your existing Supply Agreement to Alinta Energy's Standing Offer for Victoria and understand that any conditional discounts you may currently receive will no longer apply.
- You may no longer be entitled to certain subsidies and concessions as a result of your switch to a new Feed-In Tariff.
- It is your responsibility to ensure that your new metering configuration complies with Applicable Regulations and that this agreement will not commence unless and until you have complied with the Applicable Regulations.
- That a new agreement will only commence when we have confirmed in writing with you that you are a qualifying new Feed-in Tariff Customer.
- If required by the Applicable Regulations we will only vary the agreement with your consent in writing, otherwise you give your Explicit Informed Consent that the agreement may be varied by us.
- If you have completed this form without supplying us with an Australian Business Number this constitutes a representation that the electricity that you sell or supply to us is not sold or supplied to us in the course of your business and is of a wholly private and domestic nature.
- You have enclosed a copy of the Certificate of Electrical Safety and the Electrical Work Request.
- You agree that you are aware of and comply with all applicable provisions of the distribution code.
